The paper discusses various strategies but could benefit from deeper analysis on the effectiveness of these strategies. Consider incorporating case studies or examples where these strategies have been successfully implemented.

Provide more concrete implications for legal practice, particularly focusing on how legal counsels can implement the suggested preventive and reactive strategies in different types of corporate crises.

The aspect of gender dynamics within legal teams is touched upon but not thoroughly explored. Expand this discussion to consider how diversity within legal teams might influence crisis management effectiveness.

Suggest including a comparative analysis with other crisis management roles, such as financial advisors or public relations managers, to highlight the unique contributions of legal counsels.

Offer clearer directions for future research, perhaps suggesting quantitative studies to measure the impact of legal counsel's involvement on corporate outcomes during crises or studies in different cultural contexts.
